# Teaching and Talking about Gender in Law



### Highlights of the Presentation

The gathering was intended to be a forum for sharing and feedback among those who are interested and doing work on gender and women's rights. In addition, the UNIFEM Project called CEDAW Legal Education and Gender Integrated Syllabus: Curriculum Review, Educational and Teaching Support Project or CEDAW-LEGIS CURRENTS model syllabi developed by Prof. Carolina S. Ruiz Austria under the project were presented. Prof. Ruiz Austria gave a background of the UNIFEM's collaborative work with the UNDP, UNICEF, UNFPA, UN-HABITAT which make-up the UN Joint Program on the CEDAW Concluding Comments. In her main

presentation, she highlighted that 'Sex/Gender' are foundational in feminist analysis but while using the analysis to demonstrate women's subordinate status and position in society remains relevant, it has gone well beyond the male/female analysis of gender hierarchies. The three model syllabi integrating gender and women's rights were developed for the Gender and Law elective, the human rights elective and the core course on Persons and Family Relations. The gender and law website maintained by Prof. Ruiz Austria was also presented and a supplemental CD of resources was distributed to the participants.

She has also lectured at the graduate studies department of the Women and Development Program at UP CSWCD and is currently the Research Coordinator for the Development Alternatives for Women in a New Era (DAWN) project on Sexual Rights and Reproductive Health. Professor Rowena Guanzon teaches Local Government, has served as a City Mayor and handles VAW cases. Other UP-Law Professors who integrate gender and feminist theory into their courses are Dean Raul V.Pangalangan, Prof. Tony La Vina, Prof. Florin Hilbay, Prof. Dan Gatmaytan, Prof. Evalyn Ursua and Dean Marvic Leonen.
